Students will be familiarised with the rules of performing particular tasks by a probation officer (grzeczyna and socially useful work, restriction of liberty sentence, imprisonment with conditional suspension of its execution, conditional discontinuance of criminal proceedings, conditional release from the rest of imprisonment sentence, penal measures, control of probation, electronic supervision, providing post-penitentiary assistance, preparation of the convicted person for life after release from prison, supervision of the family probation officer, interviews of the adult probation officer and family probation officer, participation of the probation officer in the contact of an entitled person with a child, taking a child from an unauthorised person).
