Subject contents	Literary studies as a philological discipline. Definition of literature. Determinants of literariness of a text and functions of literature. Literary genres, types and conventions; the author - the presented world - the reader; stylistics; rhetoric; features of literary types and genres: lyric, epic, drama; the definition of poetics and a historical overview of poetics (Aristotle). Elements of literary text analysis: strophic and metrical structure of a poem; types of narrative, features of drama. The text as an object of interpretation and over-interpretation. Elements of a literary text relevant to the process of analysis and interpretation of a literary work. Selected schools of literary studies (intertextuality, hermeneutics, formalism, psychoanalysis, structuralism, semiotics, post-structuralism, deconstruction, postmodernism); preparation of a bibliography and footnotes.
