<b>Subject objectives</b>	The overarching aim of the course is to introduce students to the history of English-language literature in the twentieth and twenty-first centuries, and to a representative group of classic literary texts produced in the British Isles and the USA in the aforementioned time period; the course will also discuss so-called postcolonial literature. The course also aims to improve students' practical skills in analysing and interpreting literary; an additional aim is to deepen the participants' literary, cultural and linguistic awareness and to expand their English vocabulary.

Subject contents	Literary currents, genres and issues discussed in semester 2: Post-war literature: the literature of the Beatnik generation (Allen Ginsberg, Jack Kerouac); postmodernism in Britain and the United States (John Fowles, Paul Auster and others); Theatre of the Absurd (Samuel Beckett and his British and American successors); Postcolonial literature (based on the works of a selected author, e.g. Hanif Kuriishi); Gender issues in literature (Angela Carter); Literature and cinema; Literary life in contemporary Britain and the United States in the age of the internet, posthumanist literature, digital books and virtual libraries.
