Discussion of general issues related to judicial enforcement proceedings, in particular: presentation of the purpose of execution and enforcement proceedings, explanation of the significance of basic concepts, characterization of types of enforcement, the relationship of enforcement proceedings to other proceedings, and indication of the sources of law for enforcement proceedings. 3. General presentation of the principles of enforcement proceedings and discussion of absolute and relative prerequisites for enforcement proceedings with particular attention to the effects that a given prerequisite triggers. 4.
