Subject objectives	<p>The purpose of the course is to discuss and explain the functioning of the basic institutions of maritime security law, the process of their formation and evolution. Maritime security law is a field that has been developing in an evolutionary, dynamic way since the early 20th century. Today it is made up of regulations from international law (globally), European Union law (regionally) and national law. Numerous conventions and provisions of EU law make it necessary to amend national law. The lecture also presents the importance of the human factor in minimizing the risk of maritime accidents. The concept of safety in the largo sense also includes activities related to ensuring environmental safety, and therefore regulations for the protection of the marine environment, related to pollution prevention, as well as restoration measures and the imposition of sanctions and issues of civil liability. The purpose of the lecture is to familiarize students with the basic institutions of maritime security law, the decision-making process, the requirements for prevention and control, the importance of the institution of financial security instruments for increasing the level of maritime security. It is also important to illustrate the changes in the axiology of maritime law made in recent decades.</p>
