Subject contents	Morphology of the German language Definition of the term "grammar". Sources and concepts of grammar and its place among other fields of language knowledge. The concepts of "word" and "morpheme", classes and types of morphemes, categories of words, polyfunctionality of morphemes. Parts of speech - characteristics and features: semantic, morphological, syntactic. Inflecting parts of speech (verb, noun and pronoun, adjective, article) and non-inflecting parts of speech (adverb, preposition, conjunction, particle, modal word). Division of verbs, morphological and syntactic criteria. Valency types of verbs. Semantic category: Aktionsart. The inflectional categories of the verb: a) tenses - formal, semantic and pragmatic characteristics, b) active vs. passive voice - pragmatic value and use of passive, transformation, types of passive, ways of expressing agents, c) verbal moods in German - formal, semantic-functional and pragmatic characteristics. Modal verbs in German. Syntactic and semantic characteristics of the noun; Genus, number and case as categories of the noun; The inflectional paradigm of the noun. Inflection of the adjective; Adjective comparison. Characteristics of the adverb; Syntactic and semantic classes; Graduation. Particles and modal words; Distinction, semantic and functional characteristics, homonymy.
