Subject objectives	The aim of the course is to deepen knowledge of the history of Swedish literature, supported by a reading list that includes approximately 12 works of prose and drama, as well as a selection of lyrical pieces. Special emphasis is placed on the literary developments in Sweden at the end of the 19th century, noting their influence on later periods (with particular attention to the significant role of August Strindberg in the development of Swedish and world literature and culture).

Subject contents	The aim of the classes is to familiarize oneself with the most important issues in the history of Swedish literature, as well as to improve skills in the analysis and interpretation of literary works using literary-theoretical apparatus. An important aspect of interpretation is the cultural context. Special emphasis is placed on the phenomena occurring in Swedish literature in the second half of the 19th century and in the 20th century. A significant aspect is the work of A. Strindberg. Peasant novel. Manifestations of dystopia. The image of the welfare state and its critique in literature. Characteristics and types of detective novels. Literature's reaction to the latest social phenomena.
