Subject contents	Basic syntactic units: utterance, sentence. Types of non-sentence utterances: sentence equivalent, notification, exclamation. Organization of utterance as a unit with a communicative function: semantic-logical structure, syntactic structure. Semantic structure of utterances: modality. Formal structure of utterances: the concept of a component, boundaries of components (exercises in segmenting utterances). Syntactic analysis of a single sentence in the traditional approach (method of sentence components). The concept of connotation. The role of verb connotation in determining the sentence scheme. Signaling syntactic dependencies - description of connections between components in the traditional approach (the relationship of agreement, government and belonging) and the modern approach (syntactic accommodation). Complex sentence: parataxis and hypotaxis. Classification of complex sentences.
