Inheritance (subjective right to inherit, invocation to inherit, opening and acquisition of an inheritance, capacity to inherit, unworthiness to inherit, waiver of inheritance).3. Statutory inheritance (circle of heirs, order of inheritance, statutory inheritance of a farm).4. Will as a basis for inheritance (drafting a will, revocation of a will, interpretation, invalidity and ineffectiveness of a will, opening and announcement of a will).5. Form of a will (ordinary and special wills, witnesses to a will, content of a will, appointment of an heir, testamentary dispositions).6. Legal position of the heir (declaration of acceptance or rejection of an inheritance).7. Confirmation of acquisition of an inheritance and certification of inheritance.8. Protection of inheritance.9. Liability of heirs for inherited debts and vindicatory legatees for inherited debts.10. Reserve share (protection of the testator's closest relatives, entities entitled to a reserve share, obligated to the reserve share, amount of the reserve share, inclusion of donations and vindicatory bequests).11. Community of inherited property and division of the estate (contractual division of the estate, judicial division of the estate, effects of division of the estate).12. Agreements concerning the estate (agreement on the transfer of the estate or share in the estate).13. Securing the estate and inventory.</p>
