Subject objectives	<p>The aim of the training is to familiarise students with basic information on criminal law systems in selected foreign countries. On the one hand, attention will be paid to elements common for criminal law systems of various countries, constituting contemporary paradigms of criminal law sensu largo. On the other hand, exemplary differences in the approach to basic solutions and institutions of criminal law will be highlighted, such as the approach to general principles of penal responsibility, the issue of culpability, the scope of applied penalties and other means of penal reaction. Thanks to this knowledge the student will be able to evaluate a given system of penal law in the context of the general criteria of evaluating repressive law, as well as indicate basic differences between the Polish system of penal law and the systems of penal law of selected foreign countries.</p>
