Subject contents	<p>Defining what we actually mean historically and geographically by the term non-European. Historical and anthropological considerations; tribes, cities and states of Mesopotamia (Sumerians, Akkadians, Amorites, Babylonians, Kassites, Elamites, Gutheans, Assyrians and Babylon, Ur, Uruk, Eridu, Nippur, Sippar, Larsa, Isin and Kish). What do we mean by the civilization of the Ancient Near East (ANE) and where do we get this knowledge (sources)? The specificity of the region in terms of writing: cuneiform writing, scribal schools, libraries, literature - hymns (eršemma), lamentations (balag), prayers (šuílla and eršahunga). Understanding time and space. The established role of divination (ornithomancy, hepatoscopy), magic and exorcism. Prayers and rituals - holy wedding, royal function (New Year celebration). Good and evil, justice and sin and human existence. What do we know about the religion of the ancient inhabitants of Międzyrzecz? Pantheon (divine assembly), images of gods. Official gods, private gods and demons. How death was understood and explained; deceased and life after death. What can we learn about Mesopotamia from mythology? The most important myths (The Creation of the World - Enûma eliš, The Descent of Inanna/Ištar into the underworld, The Myth of Anzû, Gilgameš, Atrahasis, The Legend of Adapa, Etana). The relationship between god and man, the creation of man, symbols and signs (Tables of destiny, m e - the myth of Inanna and Enki). Everyday life of people of the era; cities, calendar and life cycle, social order, life and death (anthropology), love and the role of women. The role and importance of the heritage left by the ANE civilization. Traces in the Bible, the Greek and Persian world, influence on neighbors (Elam, Mari, Urartu, Hittites, Hurrians). The first discussions on the rationalism-religiosity division. The first medical, mathematical, legal, scientific and philosophical treatises (cosmogony, cosmology), wisdom literature. A brief analysis of the civilizations of ancient Egypt, the Hittites and the Israelites. Contemporary civilizations of Islam and Israel, basic threads in the development of cultural distinctiveness based on the definition of religious and social distinctiveness. Judaism and Islam as religious and social trends, the power of persistence and the price of this otherness. Prospects for development and impact on the European world. Hinduism and Buddhism - historical heritage and contemporary influence on Western civilization.</p>
