Subject contents	The lecture includes an illustrated slide presentation of the evolution of broadly understood art from ancient Egypt through ancient Greece and Rome, Byzantium, the Middle Ages, Renaissance, Mannerism, Baroque, Rococo, Classicism, Academism, Historicism, Eclecticism, Romanticism, Realism, Naturalism, Impressionism, Post-Impressionism, Vernacularism and Neovernacularism, Art Nouveau, Modernism, Postmodernism, and contemporary pluralism. The development of art is shown against the backdrop of historical, social, religious, philosophical, economic, and scientific phenomena. A special focus in the lecture is on the art of the 20th and 21st centuries, which presents the greatest interpretative and evaluative challenges to the audience. The introduction to the lectures includes a discussion of methodological problems in art history and the most important paradigms developed within this discipline.
