Subject contents	<p>During the classes, students learn linguistic ways of classifying, categorizing and interpreting phenomena of reality, including abstract reality, e.g. the world of feelings (axiological aspects of the semantics of spoken and written text). Students learn the methodological foundations of cognitive linguistics, the theory of the linguistic worldview and traditional semantics based on classical definitions. Students then become acquainted with the existence of culturally and historically diverse ethnic conditions, ways of categorization, connotations of concepts and assessment of reality based on individual layers of language, with particular emphasis on semantics.</p> <p>Against the background of ethnological aspects, students will also learn the basic mechanisms of creating sociolects. Students characterize the pragmatic, universal and exclusive features of sociolects. Students understand the socially limiting goals of creating sociolects - including the classic division into people's own and others', they also learn the mechanisms of overcoming the exclusionary character of the text using unmarked stylistic means. Students critically approach new idio- or sociolectal tendencies and semantic shifts.</p>
