Subject contents	The class presents issues of conservation problems, factors affecting decision-making processes in conservation and restoration, justifications for the choice of methods and criteria based on contemporary conservation doctrines. The history of the doctrines will be presented in the introduction. In lectures and field classes, solutions applied in practice will be shown with a broad discussion of the context-the condition of the objects, the degree of difficulty of implementation, the justification of the method of implementation. Problems of conservation presentation of museum objects will also be discussed. Methods and problems associated with the preservation of contemporary art such as installation will also be presented.
