He/she learns the principles of electronic systems of collections management, lending and making works of art available, the principles of security, developing their records for researching the art market, acquiring works for exhibition and comparison purposes. He acquires the knowledge of how to keep inventory books, deposit books, monument cards, museum movement and organize photographic documentation and present in online visual catalogs.
