Formation of a network of cities, municipal law (Lübeck, Chelmino), centres of religion, culture, manufacturing and trade. Rural settlement in the Middle Ages. Gdansk Pomerania as part of the Polish state and an independent duchy of Gdansk. Pomerania as part of the state of the Teutonic Order. The network of komturships, development of towns, relations with the Hanseatic League, urban culture at the turn of the 15th c. Incorporation into the Polish Crown - autonomy of Royal Prussia within the Crown, problems of integration with the Crown. Formation of the self-government of the nobility - the General Sejmik. Reformation in Royal Prussia. The problem of self-government of the three great Prussian cities (including Gdańsk). Religious, cultural and scientific centres in Royal Prussia. Art and culture of the 16th - 18th centuries. The partition of Poland and the incorporation of Royal Prussia into the Kingdom of Prussia. The province of West Prussia - the network of administration, garrisons. The Free City of Danzig under Napoleon. Enfranchisement and Germanisation processes in the 19th century. Industrialisation at the turn of the 19th and 20th centuries. Gdansk Pomerania as part of the Second Polish Republic and the Second Free City of Gdansk 1920 - 1939. Gdansk Pomerania during World War II.
