Subject objectives	The lecture will present the development of the visual arts (including architecture) in Gdansk and Pomerania from the Middle Ages to recent times. The main focus will be on Gdansk, but other artistic communities will also be included. Due to the vagueness and ambiguity of the term "Pomerania", the territorial scope of the lecture should be clarified: it will essentially cover the area of historic Royal Prussia (irrespective of the changing national and administrative borders over time). The focus will be on architecture, sculpture, painting and artistic craftsmanship, and, for the modern period, also on visual culture in the broader sense.
