Subject contents	Rules of Polish linguistic politeness. Correct stylistic and online communication. Spelling correctness. Propagators of the Polish language (Mioddek, Bralczyk, etc.). Personalities, Polish language knowledge tournaments, blogs, video blogs. Types of linguistic attitudes (purism, perfectionism, liberalism, "natural attitude" towards language). Criteria for the division of language styles: idiolect, sociolect, dialect, stylizations, slang. Functional styles of the Polish language: public style, colloquial style, artistic style, scientific style, official style. Aesthetics and ethics of words. Contemporary Polish spoken language vs. written language; Accent in Polish: oxytonic, paroxytonic, proparoxytonic. Practical exercises with accent, with particular emphasis on words ending in ika (ceramics), -yka (grammar), -isz (read), numerals such as four hundred and eight hundred. etc. The phenomenon of hypercorrectness. Discussion of the most common language errors. The meaning of words, confusing meanings, neologisms, fashionable words, linguistic snobbery, tautologies. Stylistic correctness. Linguistic savoir-vivre and new linguistic phenomena: fake news, hate, advertising language, linguistic manipulation, newspeak. Text organization (sentence and paragraph, introduction, development, conclusion), text coherence; text segmentation: determining sentence boundaries, division into paragraphs, introducing punctuation marks, improving spelling correctness. Types, rules and techniques of preparing footnotes; quotations and ways of quoting. Anyone can write: stylistic exercises, creative writing.
