Subject contents	The classes are devoted to the historical and literary analysis of selected ideas manifested in the writing of the 19th century and the eras or cultural formations of that time. Class units (lecture, classes) in a given semester are combined into coherent thematic cycles focusing on an issue selected by the instructor. Textual representations of the discussed ideas are described using related history of ideas literary tools (research on the history of the motif, historical themes, assumptions of thematic criticism, etc.)
