Influence of the native language on the pronunciation of German sounds with particular reference to the realisation of the rounded front phonemes and allophones of the phonemes [ç] and [x] and [r]. The prosodic plane of German (intonation and accent). (Introduction to morphology): division of verbs according to morphological criteria (regular and irregular verbs vs. strong, weak and mixed verbs), formation of tenses and tenses based on the four German infinitives, past tense of state and process, modal verbs in the construction with infinitive II of the active and passive side.
