Subject objectives	The aim of the lecture is to introduce students to the theoretical issues related to literary translation as a specific linguistic activity, to make them aware of the complexity of literary translation, its relationship with the historical and literary background, culture, genre and prosodic character of the German and Polish languages, and to become familiar with translation research methods, translation strategies and methods adapted to the nature of the original text, literary genre, expectations of the audience and the possibilities and limitations of their rendering in the target text.
