Ways of assessing the risk of bankruptcy of a company (venture) and their application in the organisation of performances. Advantages and disadvantages of different types of capital. Discussion of financial leverage and its impact on a company's bottom line. Investment decision making - evaluation criteria, net present value of money, cost of capital. Sources of capital raising for performing arts ventures, including crowdfunding for performing arts.
