Subject objectives	Within the framework of this option, the student has a choice of one of the two thematic blocks. The aim of the course is to broaden the student's knowledge and competences in the field of historical monumentology in an aspect chosen by the teacher. The optional subject is designed as a form of shaping and profiling the student's historical research interests. The subject comprises three blocks: antique design, artistic textiles and furniture. The block of classes devoted to design is intended to present the problems of modern design, differentiated from old artistic craftsmanship due to the differences in production mechanisms and social functions, and treated as one of the fields of art history. The aim of textile art historical studies is to orient the student to the problems of textile art from a domain-chronological point of view, exposing him/her to historical issues (collector, exhibition and antiquarian). Classes devoted to furniture familiarise the student with the technique, technology of furniture production and typology of these products.

Subject contents	The classes have an authorial character. Each time, the lecturer determines the subject matter of the historicist area, presenting it in the form of an individual proposal. The programme of the faculty of historicist studies takes into account various areas of historicist knowledge, above-standard or atypical programme contents, which are not given during other classes. In this way, the student has a chance to get acquainted with issues that usually go beyond the scope of traditionally understood knowledge in art history. The programme content is built on the specialised knowledge and experience of the instructor, and often goes beyond the issues available in the literature. Apart from a general chronological outline of the history of design (from the mid-18th century onwards), the subject of design historic studies deals with detailed issues of designing objects for further mass production and the history of the process of conceptualisation and realisation of designs, as well as detailed historicist issues related to design (collecting, exhibitions and the antiquarian market). Artistic textile antiquity includes an overview of weaving techniques, fabric production and function, and the stylistic and ornamental repertoire in the field of dressmaking, the production of decorative silk fabrics, tapestries and others.
