Subject contents	The classes will be divided into two thematic blocks. The first block will cover an overview of the history of clothing from antiquity to the 20th century. Participants will learn about the characteristic features of styles, materials and functions of clothing. Particular emphasis will be placed on the interpretation of clothing as an expression of identity, social status and symbolic message. The links between different styles and fashions will also be discussed, as well as methods of critical analysis of iconographic and written sources. The second block will take the form of case studies. The examples analysed will not only show methods of researching the history of clothing, but also indicate potential risks for researchers, the consequences of the analyses carried out and the practical applications of the research results in various fields of science.
