The course includes translation of authentic texts from fields such as law, administration, business, and technology. Translation strategies and the basics of technologies supporting translators are also discussed. Students learn how to edit target texts and identify and correct common translation errors. The course develops practical skills necessary for working with professional, domain-specific texts in an intercultural context.
