<b>Subject objectives</b>	The aim of the lecture is to present in chronological order the achievements of Serbian and Croatian literature from the earliest times to the end of the 19th century. The lecture provides complementary historical and literary knowledge, taking into account the Slavic context of the development of South Slavic literatures based on previous knowledge of Slavic literature of the pre-literate and literate era, as well as historical and cultural subjects. The exercises constitute an essential illustration of individual literary and cultural phenomena of this diverse and centuries-old process.

Subject contents	<p>Topics of the lecture in semester 4: Standards of the literary language (Serbo-Croatian) as the genesis of Serbian and Croatian literature until the linguistic and orthographic reform of Vuk Stefanovic Karadzic (early 19th century). The cultural significance of Vuk Karadzic's concept (codification of folk literature, language reform). The cultural role of folk poetry, its oral and written tradition. The importance of the "collective memory of the nation" for the cultures of Serbia and Croatia until the 19th century. Serbian literature: Socio-political conditions in Serbia as an inspiration for the cultural and literary perpetuation of the patriotic tradition and heroic past of the nation (genre and genre specificity of Serbian literature of the first half of the 19th century - the Serbian variant of European romanticism). French literary inspirations and patterns. Thematic innovations: evocation of Slavic mythology, fascination with the exoticism of the East, oneiric, fantastic and metaphysical themes, the cult of the Serbian Middle Ages and historical themes. Linguistic norm as the genesis of literature for the linguistic and orthographic reform of Vuk Stefanovic Karadzic. Literature in the Slavic-Serbian language (Lukijan Mušicki, Sima Milutinovic Sarajlija, Milovan Vidakovic). Serbian works of pre-romanticism. Love, occasional and civic poetry. Epic poetry. School of lyric poetry in Trieste (Dositaj Obradovic, Pavle Solarić, Joakim Vujić, Vićentije Rakić, Vikentije Ljuština, Jeftimije Popović). Epic, memoir literature, historical records, historical drama. The era of Dositaj Obradovic and Vuk Stefanovic Karadzic. Obradovic's educational role. The literary and socio-ethnic significance of Karadzic's activities. Folk art (oral tradition; romantic stylings inspired by folk art). Pietism towards oral folk literature (ethnographic, popular science and editorial activities of Serbian pre-romantics). Philosophical and literary concepts of the work of Petr Petrović Njegoš. The modern paradigm of Serbian romantic lyric poetry in the poetry of Branko Radičević. Allegorical-historical dramaturgy by Jovan Sterija Popovic. Illyricism: The phenomenon of the ideology of illyricism and its cultural scope (the significance of the activities of Ljudevit Gaj, Stanko Vraz, Janek Drašković and others). Patriotic and love poetry (Ivan Mažuranić, Stanko Vraz, Petar Preradović) and historical dramaturgy (Dimitrije Demeter). The period from romanticism to realism: The importance of political changes in Serbia in the second half of the 19th century for the formation of the historical, religious and cultural traditions of the nation (the formation of structures of modern ethnic identity). The cultural and educational role of foreign centers (Austria - Vojvodina, Hungary, Vienna, Prague). Romantic and Slavophilic inspirations in Serbian culture (the role of folklore and folklore). Historical and literary properties of Serbian romanticism: poetry (Jovan Jovanović Zmaj, Đura Jakšić, Jovan Ilić, Laza Kostić); short stories (Stjepan Mitrov Ljubiša, Laza Lazarević); dramaturgy (Milovan Glišić).</p>								
Prerequisites and co-requisites	<p>Since the subject is a presentation of the history of Serbian and Croatian literature in a historical and cultural context, the student is obliged to pass the course History of Serbian and Croatian literature of the 15th and 16th centuries - 1st semester of the second year of studies in Slavic Studies. The condition for obtaining a pass allowing you to take the exam is passing the exercises (according to the instructor's requirements).</p>
