Subject objectives	The aim of the lecture is to present in chronological order the achievements of Serbian and Croatian literature from the earliest times to the end of the 19th century. The lecture provides complementary historical and literary knowledge, taking into account the Slavic context of the development of South Slavic literatures based on previous knowledge of Slavic literature of the pre-literate and literate era, as well as historical and cultural subjects. The exercises constitute an essential illustration of individual literary and cultural phenomena of this diverse and centuries-old process.

Subject contents	Lecture topics in semester 5: Political origins of radical social movements in the era of absolutism. Political activities of Svetozar Marković. The idea of the Serbian "Omladina". Political and literary periodicals. Cultural emancipation of Belgrade. Development of national "Illyrian" cultural institutions and educational reform (activities of Josip Juraj Strossmayer). Relocation of the Croatian cultural center to Zagreb. Ideas of "Yugoslavism" (Vatroslav Jagić, Franjo Rački, Ivan Kukuljević Sakćinjski). VIII. Croatian literary variant of romanticism: lyric poetry (Mirko Bogović); short stories and journalism (August Šenoa); dramaturgy (Mirko Bogović, Luka Botić, Janko Jurković); historical novel (August Šenoa, Franjo Marković, Josip Eugen Tomić). The era of realism: The political and sociological context of Serbian realism. Emancipation of specific literary types and genres: prose (realistic-moral trend: Janko Veselinović; regional-objectivist trend: Simo Matavulj; historical-satirical trend: Stevan Sremac; social trend: Svetolik Ranković); poetry (Vojislav Ilić). The role of postulative criticism in the Croatian tradition of realism (Janko Ibler, Jakša Čedomil).
