Subject objectives	The aim of the course is to familiarize students with selected legal regulations in the field of social welfare law and social insurance law. Attention will also be paid to parental rights, including those related to the implementation of EU directives. Additionally, the course aims to acquaint students with the practical aspects of selected institutions of family and guardianship law within current codifications and extra-codification sources, using relevant doctrine and jurisprudence. The exercises are also designed to prepare students to apply the indicated regulations in practice and to develop appropriate social competencies in students. As a supplementary form of education to the lecture, the course will help prepare students to pass the exam in the subject.
