Prerequisites and co-requisites	The condition for participation in the classes is passing exams in subjects related to Polish literature (Old Polish literature, Enlightenment literature, Romanticism literature, Positivism literature, Young Poland literature) in the semesters immediately preceding the subject. Ability to analyze and interpret literary works, knowledge of the history of Polish literature and universal literature of periods preceding the literary era discussed in a given semester. In exceptional cases, the person conducting the classes may waive the above requirements. In the case of foreign students, knowledge of Polish is required to enable understanding of the content presented during the classes and active participation in them.
