Development of yers - place in the vocalic system, effects of disappearance or vocalization, chronology, irregularities of development. Development of sonants. Stages of development of nasal vowels. The main processes transforming the consonant system (palatalizations and dyspalatalizations).

Which of the principles of modern Polish orthography are related to the history of the Polish language? 2. Review the orthographic proposals of J. Parkoszowicz (based on the text of his treatise, especially the so-called "Promise") and S. Zaborowski. 3. Reconstruct the vowel system of the Proto-Slavic language. Justify with examples the impoverishment of the vocalic subsystem on Polish soil. 4. Using the indicated examples, discuss the origin of the vowel e in Polish. 5. Present the essence, chronology and consequences of the articulation. 6. How did the so-called onset groups *ort-, *olt- and mid-glottal *tort, *tolt, *tert, *telt. develop in Slavic languages? 7. Discuss the process of contraposition. In what word forms did it occur? Give your own examples. 8. Briefly present the phenomenon of assimilation (backward and forward), dissimilation, and simplification and enrichment of consonant groups. 9. What continuants gave on Polish soil psl. sonants r i ř? 10. Briefly discuss the essence, causes and effects of the process of vocalization and reduction of yers. 11. From the first verse of Psalm I (from Psf), choose 7 words in which there used to be yers (in the middle and in the articulation). What happened to them and why? What is the phenomenon of substitution lengthening? 12. Briefly discuss the causes, timing and geography of the disappearance of stippled vowels. 13. Why do ó : o differ in pronunciation and writing to this day? 14. How to determine the Proto-Slavic color and Old Polish ilo time of modern nasal vowels? 15. How under the influence of i and j changed consonants: s z p b v m t d r? Give your own examples. 16. Briefly discuss the causes and timing of palatalization of back-language consonants. 17. Give and discuss the sources of vowel length in Polish. 18. How and in what monuments were long vowels marked? 19. Discuss the dyspalatalization of different types of consonants, especially labial and so-called functionally soft consonants. 20. Explain the genesis of the consonants c dz ć dź š ś ż in Polish. 22. Why in Polish we write the voice [ž] in two ways: ž and rz.
