Expansive, regressive and declined endings in the declension of nouns. Evolution of the declension of adjectives. The variation of pronouns. The emergence of plural declension. The old division of verbs into conjugations and classes. New Polish conjugation -am, -asz. Endings of the present tense. Development of the imperative mode. The emergence of the new compound past tense and the disappearance of simple past tenses (aorist and imperfect). Future simple and compound tenses. Stages in the development of the conditional mode. The infinitive. Transformations of participles.
