Subject contents	The classes are devoted to the historical and literary analysis of selected ideas manifested in the writing of the 20th century and in the eras or cultural formations of that time. Class units during the semester are combined into coherent thematic cycles focusing on an issue selected by the instructor. Textual representations of the discussed ideas are described using related idea history tools (research on the history of the motif, historical themes, assumptions of thematic criticism, etc.)		
Prerequisites and co-requisites	Elementary knowledge of the history and theory of literature and the ability to analyze and interpret literary works based on the basic tools of poetics. In justified cases, the instructor may waive the above-mentioned requirements. In the case of foreign students, it is necessary to know the Polish language well enough to understand the content presented during classes and actively participate in them. Obtaining a pass in the subjects "History of literature as a history of ideas (19th century) - exercises" and "History of literature as a history of ideas (19th century) - lecture".
