Example issues/ example questions/ tasks being completed	1. Written assignment: A review of an opera performance (available on YouTube), the link to which will be provided by the teacher at the end of the semester. The review should be 2,500–3,000 characters (including spaces). Detailed guidelines will be provided during class. This assignment is mandatory for all students. Failure to submit it by the end of the semester will result in failure of the course, regardless of the student's attendance record. 2. Class attendance: The consequences of absence may be remedied by demonstrating knowledge of the material covered during the missed class. This is done by completing a written test consisting exclusively of multiple-choice questions based on a brief summary of the topic (no more than one page) made available by the teacher in advance. The test comprises 10 questions, and students must answer at least 7 correctly to pass. If unsuccessful, students may retake the test on one further occasion at a different date.
