Simulations of Arbitration Processes: Participation in simulations that imitate real tax arbitration processes. Practical application of arbitration rules and procedures in specific tax dispute scenarios. 3. Case Study Analysis: Working with real case studies on tax disputes. A discussion on strategies and approaches to resolving various types of tax disputes. 4. Negotiation Techniques Workshops: Training in negotiation techniques specific to tax disputes. Practical exercises in negotiations and mediations. 5. Preparing Documentation for Arbitration: Learning to prepare pleadings, arbitration applications and other legal documents. Analysis of formal and procedural requirements in tax arbitration. 6. Debate and Discussions: Organizing debates on key issues and challenges in resolving tax disputes. Discussions on ethics and best practices in tax arbitration. 7. Resolution of Fictitious Tax Disputes: Participation in exercises involving solving fictitious but realistic tax dispute scenarios. Evaluate different dispute resolution options and strategies. 8. Study Visits and Guest Lectures: Possible visits to tax arbitration institutions or tax offices. Guest lectures by experts in the field of tax law and arbitration. 9. Assessment of Tax Judgments and Decisions: Analysis and evaluation of actual court judgments and arbitration decisions in tax matters. 10. Design Work: Development and presentation of a project regarding a specific case of a tax dispute, using the acquired knowledge and skills.
