**At the same time I acknowledge, in accordance with the General Data Protection Regulation of 27 April 2016, hereinafter referred to as 'the GDR', that:**

1. The Controller of my personal data is the University of Gdańsk, located in Gdańsk (postal code 80-309) at 8 Jana Bażyńskiego Street.

3. My personal data will be processed for the purpose of organizing and conducting THE UNIVERSITY OF GDAŃSK JUBILEE MASCOT DESIGN AND NAME competition.
4. The legal basis for the processing of my personal data is Article 6(1)(a). GDPR - consent of the data subject.
5. Providing personal data is voluntary, but necessary for the above mentioned purposes.
6. My personal data will be processed ,on behalf of the data Controller, by the authorized employees only, for the purposes referred to in point 3.
7. My personal data will be stored as per the consent, during the period of its validity, however, no longer than the period necessary to achieve the objectives referred to in point. 3 - until 31.12.2020. In the event of winning the competition - until 31.12.2026.
8. My personal data will not be made available to external entities, except for the cases provided for by law.
9. I am entitled, by the rules set out in the GDPR regulations, to:
  - The right to access the content of my data,
  - the right to rectify them when they are inconsistent with the actual status,
  - the right to erasure, restriction of processing, as well as transfer of data, in cases provided for by law,
  - the right to object to data processing,
  - The right to file a complaint with the supervisory authority - the President of the Office for Personal Data Protection - if I consider that the processing of my personal data violates the regulations on personal data protection.
  - The right to withdraw the consent at any time without affecting the lawfulness of the processing, made on the basis of the consent before its withdrawal.
