








Results of the 4th edition of the 'Visiting Professors UG' programme. 14 laureates from all over the world.

The Committee of the 'Visiting Professors UG' Programme has selected 14 scientists from 12 countries - South Africa, Germany, Canada, Iran, the United States, Colombia, Uzbekistan, Japan, Norway, the Netherlands, Rwanda and Austria - to visit the University of Gdańsk in 2024. This year's edition of the programme attracted record interest.



The Visiting Professors programme is a strong element of our 'at home' internationalisation strategy. It is about opening our campus to foreign visitors and, above all, about diversity, multiculturalism and multilingualism in our academic life. Thanks to the programme, students and researchers have the opportunity to meet excellent scientists from all over the world,' says UG Vice-Rector for International Cooperation, Professor Anna Jurkowska-Zeidler.

In the fourth edition, the laureates will conduct 164 teaching hours in the form of classes for students, open lectures, seminars, and meetings with students and staff. These activities will significantly increase the internationalisation of education.

'Each of the scientist's visits has the potential to be the start of something great. We have many examples where an innocent exchange of e-mails or a conversation at a conference started a long and fruitful cooperation resulting in joint publications and projects,' said Vice-Rector for Research, Professor Wiesław Laskowski.

The fourth edition of the 'Visiting Professors at the University of Gdańsk' programme attracted record interest among University of Gdańsk staff carrying out research and/or teaching activities in cooperation with foreign researchers.

Thirty-eight applications were submitted for a total of PLN 613 500.

The application review committee assessed the submitted applications in terms of the reputation of the invited researcher, the prestige of their home research centre, the strengthening of existing international cooperation between centres, the interdisciplinary nature of the research topic, the impact on the quality of education and the tangible scientific effects of the visit.

The research proposed by the foreign guests will be carried out in the humanities and social sciences as well as in the sciences and natural sciences. Cooperation between UG staff and scientists from recognised institutions worldwide will contribute to strengthening the scientific potential of the university. The research's direct effects are expected to include new publications in internationally renowned journals and jointly submitted scientific projects.

ON THE FUTURE OF INTERNATIONALISATION. UIC MEETING AT THE UNIVERSITY OF SILESIA



The internationalisation strategy of Polish science, the challenges of European University alliances, and the conclusions after the EAIE conference in Rotterdam were the topics discussed during the stationary meeting of the University Internationalisation Commission. The UIC was established by the Conference of Rectors of Polish Universities in November 2022 and brings together university plenipotentiaries for international cooperation from all over Poland.

The meeting, which took place on December 8 at the University of Silesia in Katowice, was opened by UIC President, Professor Anna Jurkowska-Zeidler and UIC Vice-President, Professor Tomasz Pietrzykowski from the University of Silesia.

The floor was then taken by the Rector of the University of Silesia, Professor Ryszard Koziołek, who talked about the events prepared as part of Katowice's obtaining the title of European City of Science 2024. The idea behind the celebrations is to organise 50 themed weeks full of scientific and popular science attractions, as well as cultural, sporting and artistic events created by the academic and municipal communities. Progress in the preparation of the National Internationalisation Strategy was presented by the Director of the Polish National Agency for Academic Exchange (NAWA - Narodowa Agencja Wymiany Akademickiej), dr Dawid Kostecki. The inaugural meeting with the Ministry of Education and Science on this initiative was held on September 22, 2023. The NAWA Director outlined the plan to build a national strategy for the internationalisation of higher education and science and invited the community to collaborate.

The key issues related to internationalisation, i.e. micro-certifications and the legal status of European University Alliances, among others, were presented by the UIC President. 'In particular, partners from European University Alliances draw attention to the need to define clear rules for the delegation of staff, joint affiliations, access to research infrastructure, processing of personal data, management of intellectual property or rules for joint procurement of goods and services,' said Professor Anna Jurkowska-Zeidler. After the break, the topic of European Universities was developed by Professor Dominik Antonowicz, and dr Marta Jaworska from the Nicolaus Copernicus University in Toruń.

The academics talked about research on European Universities conducted at the Nicolaus Copernicus University Department for Research on Science and Higher Education.

In Polish universities, this programme is viewed strategically. The long-term future of a university is linked to alliances. The main barriers to the development of the European Universities initiative identified in the study are:

- legal and regulatory constraints incompatibility of national legal systems;
- organisational constraints e.g. cumbersome bureaucracy or lack of synchronisation of academic calendars;
- financial constraints the need to involve funds from outside the consortia, e.g. to finance mobility programmes or to strengthen the language skills of academic staff.

At the end of the meeting, the experience gained during the presidency of the Transform4Europe consortium was shared by the Plenipotentiary for International Cooperation at the Faculty of Social Sciences of the University of Silesia, Professor Małgorzata Myśliwiec.

Expert panels identified the main challenges in internationalisation. The UIC's aim is coordinated inter-university cooperation in these areas, which will allow consistent communication with the Ministry of Science and Higher Education and international institutions related to, for example, the European Union.



INTERNATIONAL COOPERATION OF THE CRASP AND CRPU COMMITTEE MEETING

The International Cooperation Committee of CRASP and the University Internationalisation Commission of CRPU jointly deliberated in Poznań as part of the conference 'Foreign students in Poland 2024'.

On 7-9 February 2024, the Poznań University of Technology hosted a conference entitled 'Foreign students in Poland 2024'. The accompanying event was a joint meeting of the International Cooperation Committee of the Conference of Rectors of Academic Schools in Poland and the University Internationalisation Committee of the Conference of Rectors of Polish Universities. The event was chaired by the Vice-Rector for International Cooperation of the UG, the Chair of the University Internationalisation Commission of the CRPU, Prof. Anna Jurkowska-Zeidler.

During the meeting, Prof. Anna Jurkowska-Zeidler presented "New priority directions for international cooperation and attracting foreign students: experiences and opportunities". The speech "The role of Polish engineering organisations in recruiting foreign students" was given by Prof. Andrzej Nowak from Auburn University. The discussion also included the EUA's recommendations on the shape and structure of FP10 and the role of the 'Polish Returns' and the 'Gen. W. Anders Scholarship Programme for the Polish Community' in strengthening ties with the Polish academic community.

The conference 'Foreign students in Poland 2024' was organised by the Conference of Rectors of Academic Schools in Poland, the Poznań University of Technology and the Education Foundation PERSPEKTYWY.





Cooperation between European Universities and Ukrainian HEIs. Meeting at the University of Strasbourg and the European Parliament

How to support Ukrainian universities while introducing them strategically to European Union initiatives? This was discussed by representatives of the European Universities programme members and Rectors of Ukrainian universities at a meeting with the Vice-President of the European Parliament, Ewa Kopacz, and representatives of the European Commission.

This was the first meeting of its kind, bringing together state authorities, the European Parliament, the European Commission, Ukrainian universities and alliances of European Universities.

The SEA-EU alliance was represented at the conference by the Vice-Rector for International Cooperation, Professor Anna Jurkowska-Zeidler.

The meeting took place at the University of Strasbourg and the European Parliament on March 13 this year. The conference 'European and Ukrainian Universities Cooperation: state of play and future perspectives' consisted of three panels. In the first, representatives from both sides spoke about the current state of strategic cooperation between European and Ukrainian universities.

Best practices and supporting initiatives were identified by representatives of alliances of European Universities: EUniWell, SEA-EU, EC2U, ENHANCE, and CIVICA.

Deputy Minister of Education and Schooling of Ukraine Mykhailo Vynnytsky and Deputy Minister of Education of the Czech Republic Jiří Nantl also participated in the conference.

'Odessa I. I. Mechnikov National University has been an associate partner of the SEA-EU alliance for almost two years now, but we are constantly striving and making efforts for Ukrainian universities to gain full membership status in the European Universities programme. This is what determines their funding from the Erasmus+ programme. I am glad that as SEA-EU we had the opportunity to present the fruits of our cooperation in front of the Vice-President of the European Parliament and representatives of the European Commission,' says Prof. Anna Jurkowska-Zeidler. 'We showed that cooperation after February 24, 2022, came about naturally, irrespective of EU funding, as a form of aid for Ukrainian higher education. However, if we want to further support Ukraine and prepare it to join the EU, these initiatives need systemic support from the European Commission.

SEA-EU as an alliance of 9 coastal universities has a multifaceted cooperation with Odessa I. I. Mechnikov National University (ONU). Also attending the meeting at the University of Strasbourg was ONU Vice-Rector for Research, Teaching and International Cooperation prof. Andrii Smitiukh.

Authorities from SEA-EU partner universities discussed support for the Ukrainian university during events such as Ukrainian Day, held as part of Governing Week at the University of Gdańsk. To date, support for ONU's participation in SEA-EU has been made possible through funding from the 'Solidarity with Ukraine' programme run by the National Agency for Academic Exchange (NAWA).

DR KATARZYNA ŚWIERKWITH THE STAR OF DEVELOPMENT AWARD

Director of the UG Office of Science, dr Katarzyna Świerk, has been awarded this year's Stars of Internationalisation in the Star of Development category! This is an award for people who have contributed most to the internationalisation of Polish universities.

This is a great distinction and a great joy for me. But it is also a motivator to keep doing more and better and to look far into the future because the road to academic excellence is very long and bumpy,' said the winner. 'This award recognises my activities in recent years, which would not have been possible without the openness and trust of the rector's authorities. It is, in fact, an award for all of us, for the University of Gdańsk, which I have the honour to represent.' The award chapter highlighted the diversity of dr Katarzyna Świerk's activities, who at the same time heads the UG Office of Science and is the UG Plenipotentiary for Open Access to Scientific Publications. In addition, the laureate has dealt with theoretical and practical problems of higher education for several years. She works with the Institute for Higher Education Development and is a certified EU auditor for HR Excellence in Research and Horizon 2020/Horizon Europe.

In this year's edition, awards were presented in nine categories. The winners' contributions to, among other things, promotion, education or management in the field of internationalisation were recognised. The awards were received by vice-chancellors, deans, academics and administrative staff of universities from all over Poland.





This was the seventh edition of the prestigious Star of Internationalisation award, granted as part of the Study in Poland programme, an initiative carried out by the Educational Foundation 'Perspektywy' and the Conference of Rectors of Academic Schools in Poland. 'The award promotes people who open our higher education institutions to other experiences and cultures,' says Waldemar Siwiński, founder of the Perspektywy Educational Foundation. 'It is an important community distinction because the work put into the internationalisation of universities is often overlooked, yet it is of great value.'

In last year's edition, the title of Management Star went to the Vice-Rector for International Cooperation, Professor Anna Jurkowska-Zeidler. The jury paid particular attention to the organisation of the 'Solidarity with Ukraine' conference and the micro-grant project for Ukrainian scientists.
