Founded in 1425, KU Leuven is the oldest university in Belgium, as well as being the oldest still existing Catholic university anywhere in the world. With more than 42,000 students, it's also Belgium's largest higher education institution and is considered to be one of the most prestigious research universities in Europe. The Faculty of Law is ranked 25th in the Times Higher Education World University Rankings. The University is ranked number 45 in the world.
